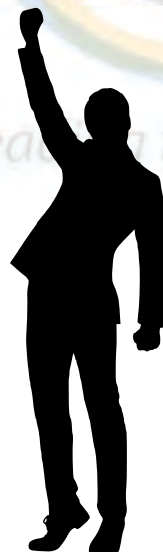
members and getting to know them better through the fun event that is scheduled after each meeting.

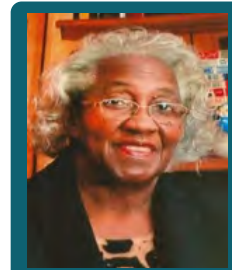

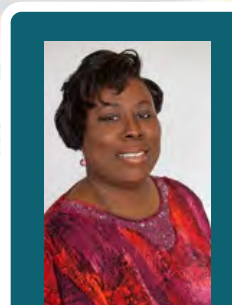

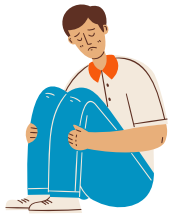

Almost half of child labor happens in Africa (72 million children), followed by Asia and the Pacific (62 million).

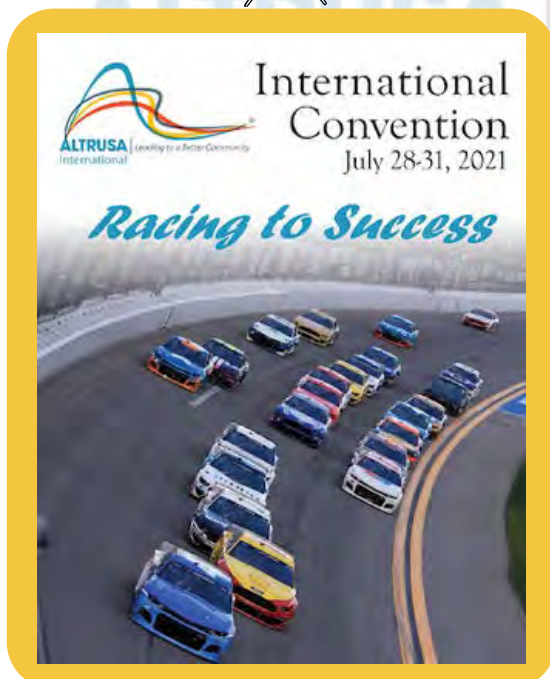
70% of children in child labor work in agriculture, mainly in subsistence and commercial farming and herding livestock.

Electrolysis at Historic Yates Mill County Park

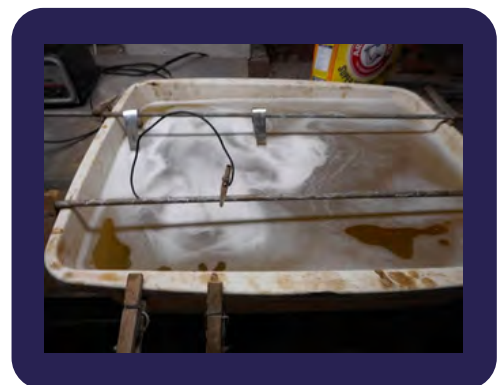
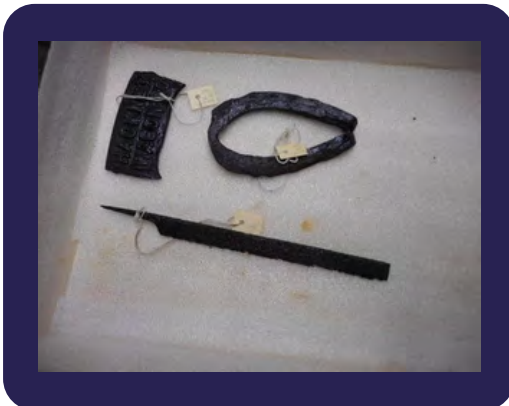

Altrusans come from a variety of backgrounds and possess many different talents and skills. Altrusa International of Raleigh, Inc. is a small club. In order to make a larger impact on our community, we concentrate on volunteering with a few partners in order to build continuing relationships. In the past, we have done landscaping and planting of native species at the park. Our latest endeavor with Historic Yates Mill County Park involved assisting them in preserving their archaeological artifacts. Historic Yates Mill County Park is a functioning 18th century grist mill and dam complex that also includes natural areas, trails and a large millpond. While they have had professional archaeological excavations at the park in the past, they occasionally uncover artifacts during regular maintenance projects. At times, park patrons will turn in artifacts they have found while hiking the trails.

One of our members, John W. Clauser, Jr. is a retired historic archaeologist. As an on-going project and as the need arises, John will identify and date recovered artifacts and provide advice on their display or disposition. Many of these artifacts are metal, as that material is more likely to survive over time. In order to clean the metal artifacts and conserve them for future use, they often need to be subjected to a process known as electrolysis.

Electrolysis stops rusting and removes scale (large pieces of rust) from metal artifacts. The artifacts are put into water with an electrolytic material, such as washing soda. An electric current is passed through the artifact using a small battery charger. The amount of time the artifacts are in water depends upon their size and the amount of rust present. After electrolysis is completed, the artifact is treated with tannic acid to inhibit additional rusting, and the final step is to spray the entire artifact with acrylic.

The range of artifacts treated so far include horse shoes, gears, nails, a cap pistol and various and sundry machinery parts. While some of the treated artifacts are put on display in the park's visitor's center, most are curated in their study collection for future research. Budgetary restraints on the park preclude their hiring an outside consultant to conserve the artifacts. Altrusa International of Raleigh, Inc. is pleased to be able to provide this service and save these pieces of history.

We remain an active club and have continued to work through the same challenges that all our Altrusa brothers and sisters have been facing. While we have continued providing zoom access for our meetings, most of our members participate in-person. We were also pleased that 40% of our membership chose to attend the District Three Convention in Greenville, South Carolina.

In addition to our projects, we have diligently worked to complete and file with District Three our: Annual Report, Recap of Existing Strategic Plan, Strategic Plan for 2022-2027, and Amendments to our By-Laws. Our 2021-2022 Budget has been adopted.

We have enhanced our scholarship program this year. In addition to the two scholarships that we annually award to deserving high school seniors, our Club will also host a fundraising event in May to allow us to provide at least one and possibly two additional college scholarships. In addition, we will provide \$500 worth of scholarships to the local 4-H day camp program and two scholarships for youth from Jefferson County to attend the summer camp program at the Florida Sheriff's Youth Ranch near Live Oak, Florida.

Our members continue to collect books for children in grades one through five for local distribution, provide reading resources for a first-grade classroom at our local charter school, and provide food items monthly for the Backpack Buddies program in our county.

In February, we held our Annual Souper Tuesday soup and sandwich lunch. We were extremely pleased with the number of lunch orders we received from businesses and individuals in the community. In conjunction with the lunch, we held a raffle for a one-week stay at a river-front home on St. George Island, Florida. Our District Three Governor Elect, Dimple Overstreet, was the prize winner. Our Club is planning a "Lunch with Dimple" while she is at the beach home. We were able to fund high school, 4-H camp, and Sheriff's youth camp scholarships from the proceeds of the lunch and raffle. Following the fundraiser lunch, soup and desserts were delivered to our SOS veteran.

At Easter, we resumed our Bunny Love program to recognize those living in our local nursing home facilities. Each resident was provided a hand-made card of love and encouragement and a stuffed Easter Bunny. Even though we could not personally deliver our "elder love" gifts, we were able to utilize nursing home staff to make the deliveries for us.

We continue to be aware of the importance of "fellowship opportunities for our members during this COVID season. Our Care Committee continually monitors the needs of our members and their families and provides cards, phone calls, food, and transportation assistance, as needed.

We would like to acknowledge the assistance provided to us this year by our District Director, Karen Wishart and by Governor Kitty McElhaney. In addition, we express our thanks to our fellow Club member Joanne Brown for her many accomplishments as a District Three Director this past Biennium.

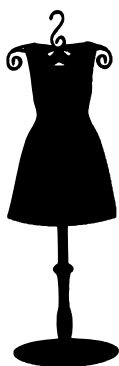
On Monday, February 22, 2021, St. Augustine Altrusan Brian Bowman received the prestigious de Aviles Award from the City of St. Augustine City Commission. The de Aviles Award is presented to those who have been 'identified in the field of public service or those well-known and respected by the citizenry who have dedicated and honorable service to the community of St. Augustine and St. Johns County.'

Brian has been a member of Altrusa since 2012 – he is actually our first male member. But prior to his officially joining our club, Brian has been involved with us alongside his wife Louise who has been a member for over 40 years. Throughout his involvement with our club, Brian has always been there to volunteer from reading applications for our scholarships to providing the tools and help for our highway cleanups to bringing his re-enacting characters as escorts for our models at our annual fashion show.

Brian's other contributions to our community are many. He has been a presenter of living history since the 1970s, currently serving as the President of the Historic Florida Militia, St. Augustine's prestigious historic re-enactors' organization. As a re-enactor, Brian has represented many historic characters – from Ponce de Leon landing in Florida throughout St. Augustine history to Victorian times; but he prefers to portray common people such as 16th century soldiers.

St. Augustine Vice-Mayor, Nancy Sikes-Kline said in her nomination of Brian for the de Aviles Award, 'Mr. Bowman's personal dedication for over 35 years of service to the preservation and restoration efforts of St Augustine's Living history, stands out as one of the most continuously visible efforts in our community.' Her nomination also recognized his 'long-standing service bringing awareness to the fact that historic preservation is more than saving historic structures and sites. Historic preservation is also about preserving cultures in tangibles ways through living history.'

Brian is currently employed by the Ponce de Leon's Fountain of Youth Archaeological Park where he serves as the Facilities Assistant Manager and is the thatcher of American Indian and European buildings of 1565 landing moment. Brian has been instrumental in making the facilities of the Park available to our club for our meetings and for the planting of the beautiful magnolia tree recognizing the work of Altrusans in St. Augustine.

In April 2021, Altrusa St. Augustine established a Little Library at 180 Oneida St. in St. Augustine – in the heart of the historic Lincolnville district of the city.

The location of the library is in an ideal one where there is a lot of foot traffic – both from residents of the area and tourists. The Little Library will provide access to books for those, who for some reason or other, may not always have that access. St. Johns County has several public libraries; but there may be those that may not have transportation to the library. Tourists, just passing by, may find an interesting read. Other folks may not have the funds to purchase books. We hope that our Little Library will provide that access and encourage a love of reading in others. Altrusa members will monitor the library to ensure that it is stocked with books for all ages.

Altrusa provided all the materials for the Little Library which was then constructed by the students of the Pedro Menendez High School Building Construction Program in the Academy of Architectural and Building Sciences. Mike Rosenberg is the teacher who leads these students. Over the years, the students have built several Little Libraries that are scattered throughout the county. The students have also rebuilt a Middle School's greenhouse damaged in one of the hurricanes. Mr. Rosenberg and his students enjoy working with organizations throughout the county to give the students practical experience in building construction. All the organizations have to do is ask and provide the materials.

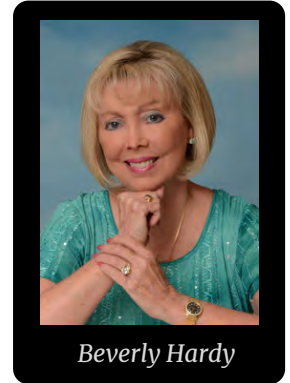
