Parliamentarian Pointer

WHO THE HECK IS ROBERT AND WHY DO WE CARE ABOUT HIS RULES?

Henry Martyn Robert, was a Brigadier General in the Army, Chief of Engineers, active during his lifetime in church, civic and educational organizations. While stationed in San Francisco, Henry began his work developing standard rules of procedure for deliberative assemblies. He and his wife were very involved in several organization seeking to improve social conditions. They found that with the melting pot of people now part of San Francisco, in the late 1800's, they needed a uniform set of procedures for civic minded people to use in the several organizations they belonged to, since everyone had their own set of rules depending



on where they were from. He used the rules and customs for carrying on business from English Parliament, along with Thomas Jefferson's *Manual of Parliamentary Practice* and *Cushings Manual* to develop the first "Robert's Rules of Order" in 1876. Although, he entitled the document "*Pocket Manual of Rules of Order for Deliberative Assemblies*", the publisher changed the name. They found that Parliamentary Law that was adapted from English Parliament to form the rules for our legislative bodies needed revisions for use by voluntary societies. Henry Robert created the very first version and many of the subsequent revisions. Robert's Rules is now in its 12th Newly Revised Edition. Each edition has been used to interpret the rules further and answer newly arising questions. The work has been carried on by Henry's son, daughter-in-law and grandson over the years. Henry had the foresight to establish a "trust" which has carried on the work of developing the rules over the changing times and will continue to do so for years to come.

So why do we care about the rules? Well, it helps us to operate our organization in a fair and meaningful way. Each member has the right to share ideas, discuss matters, voice opinions in an orderly fashion. All actions to be taken by a Board, Club, District or Organization come before the body via a *main motion* which is then debated with each person having an opportunity to speak, *for a set amount of time and limited number of times*, in order to avoid the discussion being dominated by any one person or going on for hours. If the proposal needs "tweaking" then it can always be *amended* or *referred to a committee* or *postponed to a time certain*, so further investigation or more information can be obtained. If something is adopted by the group that they then wish to change, it can always be *rescinded* or they can *amend something previously adopted*, under the proper circumstances. If one is tired of the discussion or believes it has lasted long enough, they can *call the question* in an effort to end debate. Finally, once all the work is done or if we simply need a break, one can call for *recess* or *adjournment*. Robert's Rules are adaptable and each entity can adjust how they operate via specific *"rules of order"* for each organization.

Within the "rules" lies numerous avenues to accomplish the will of the membership while allowing all to participate in the process.

The Mamie L. Bass Service Award

The Mamie L. Bass Community Service Award was established by the International Board of Directors in July 1963, as a memorial to the first National President of Altrusa. The name was changed to the Mamie L. Bass Service Award by the International Board of Directors in July 1975.

OBJECTIVES

- To stimulate interest in developing action programs in the community that fall within thescope of Altrusa's program of service.
- To encourage members of local Clubs to participate actively in service projects designed tomeet specific local needs.

The Letha H. Brown Literacy Award

The Letha H. Brown Literacy Award was established by the International Board of Directors in July 1993, to honor Past International President Letha H. Brown, who, in 1977, introduced literacy as a major emphasis of the organization.

OBJECTIVES

- To stimulate interest in developing active literacy projects to serve their community.
- To create an awareness of Altrusa and its commitment to literacy.
- To encourage members of local Clubs to participate actively in literacy projects designed tomeet specific community needs.
- To recognize outstanding Club achievement in service to the community.

Dr. Nina Fay Calhoun International Relations Award

The Dr. Nina Fay Calhoun International Relations Award was adopted in 2003 as a memorial to the only International President who served two terms and who focused on the International aspect of our organization.

OBJECTIVES

- To encourage and to stimulate international relations
- To create an awareness of other cultures and people of the world
- To recognize outstanding club achievement in international relations

DISTRICT AND INTERNATIONAL COMPETITION

- 1. Service projects nominated for the Dr. Nina Fay Calhoun International Relations Award are judged each year at District Conferences. First-place winners from each District are entered in the competition at the International level. Established judging criteria are usedby Districts and by International.
- 2. One (1) service project from Clubs-At-Large is included in the competition by International. The International Membership Committee organizes the selection process for projects for Clubs-At-Large.

Ernestine Milner Program Excellence Award

PURPOSE: This award is based on the concept that good program planning is the key to a successful club. Ideally, programming should provide Altrusans with opportunities for fellowship, service, personal and professional growth in addition to influencing member participation and attendance.

Outstanding Community Service Award

PURPOSE OF THE AWARD

- To stimulate each club to make community service a priority focus of their club by demonstrating at least a minimum percentage of membership participation, finances and volunteer time in their community service activities.
- To recognize each club that achieves these goals on an annual basis.

CRITERIA

- 1. At least 75% of the total membership must have volunteered a minimum average ofthree (3) hours each during the course of the year on the club's community service or fund-raising events.
- 2. The club, as a whole, must have provided at least 300 hours of volunteer time during the course of the year in providing direct service through projects in their community or in raising funds to underwrite the cost of the community service projects.
- 3. The club must have given at least \$1,000 during the course of the year to underwrite the costs of the

Newsletter Award

PURPOSE: To promote effective communication within and beyond the club. Club newsletters are intended to be timely, concise and reader-friendly ways of communicating with current and potential members of Altrusa International, Inc. Electronic distribution makes that cost effective, timely, and possible for all. Note* All club newsletter editors would do well to use the judging criteria as a planning guide from the beginning of the club year.

CRITERIA: Four areas - Content (60 points), Format (13 points), Readability(10 points) and Distribution (18 points) for a total of 101 points per judge or 303 overall.

Todd Jordan Yearbook Award

PURPOSE: A yearbook serves as a reference tool in which members can find pertinent information. This award is presented to clubs who publish a yearbook and submitted a completed award submission form by January 31, 2022. The District Three Board encourages each club to produce a yearbook as a much-needed communication tool. The club yearbook should contain local, district and international information.

CRITERIA: Six areas - Format/Usability (10 points), Club Information (60 points), District Information (12 points), International Information (13 points), Altrusa Information (8 points) and Distribution (10 points) for a total of 113 points per judge or 339 overall.

Club Revitalization Grants

IDEAS and TOOLS to RECRUIT and GROW

Club revitalization is actually relevant to ALL clubs. Having a warm and welcoming attitude will create the right environment for members to thrive.

- 1. Make recruiting new members the TOP priority of your club.
- a.Ask your members for recruitment ideas and learn to focus on the solutions to any issues that come up in your club.
- b.Membership keeps us strong. Strive to strengthen the Membership Committee with people and ideas that focus on actively recruiting new members. Remember: ACTION on those ideas is what really matters!
- 2. Retention of current members is just as important as recruiting new ones. Members who are happy and satisfied with the work and relationships of the club usually stay members and in vite others to join.
- a.Get a reading of how members feel about the club- give an annual SURVEY so you can all determine how to improve.
- 3. Develop a recruiting strategy with specific GOALS. Create a recruiting folder to give to potential new members. Include a brochure about your club with information on who they can call or email, your website and projects your club is involved with.
- a.Be creative in what to put in your folder. Develop a display or "Thermometer" graph showing progress toward your goal.
- 4. Organize INTERESTING meetings! One of the top reasons members leave is ineffective club meetings. We need interesting and productive meetings.
- a. Consider sending an email with a detailed agenda with the treasurers report and reports from the committees and spend half your meeting on business and the rest of the meeting on socialing or a fun activity.
- 5. ADVERTISE! Members will not join if they don't know about you. You can put out flyers and posters in the library or community bulletins or coffee shops.
- a. Members can send out emails to all their contacts for an upcoming event. Social media is a great way to get the message out about who you are and what you are doing.

Partnering with other clubs or organizations on projects is also good. Join the Chamber of Commerce or a Speakers Bureau. Get an article published in the newspaper about what you are doing in the community. Host an event at your local library or hospital. Invite your family, friends and coworkers to a meeting. Wear your Altrusa Pin!



International Bylaw Changes

2021 INTERNATIONAL CONVENTION: BYLAW CHANGES

There were 34 proposed changes to bylaws at International Convention this year and all of them passed. While that sounds like a lot to review and understand, as **Donna Johnson, International BRR Chair**, **Gainesville**, **FI**. pointed out, several were repeated for the International, District and Club levels. So, in that respect, there were only 1/3 as many actual bylaw change concepts to review.

Most changes were in response to circumstances caused by the pandemic. Agenda Item 21.01 (International Bylaw, Article V, Section 4), removed the sentence "All votes shall be cast in person" and kept the sentence "No votes by proxy shall be allowed." The change eliminated redundancy and supported subsequent bylaw changes involving electronic voting.

Item 21.02 (International Bylaw, Article VI, Section 3) referred to the scheduling of International Conventions, allowing for the exception of a national or international condition of emergency which makes the holding of a Convention "impossible." "Impossible" was changed to "impractical" to provide a more realistic and reasonable standard to prove. The stipulation was added that upon approval from the Board of Directors, a Convention may be held in person, through electronic means or both.

In Item 21.04 (International Bylaw, Article VIII, Section 1) language was added to state that voting may be held by electronic means during meetings of the Board of Directors.

"A member of the Board of Directors can participate in any meeting by or through the use of any means of communication by which all members participating can simultaneously hear each other during the meeting."

At the club level, **Item 21.22 (Club Bylaw, Article XIII, Section 1)** incorporated procedures for election of officers in the event that normal elections could not be held. Elections may be held by electronic balloting, as proscribed by the Board of Directors. Under this process, votes may be cast for persons other than the nominees listed on the ballot by writing in the name of the person and the office.

Also of interest to Clubs is **Item 21.33 (Article XIV, Section 1).** The existing article states that Standing Committees shall be:

Service
Membership Development
Communications
Finance

The added language states that "Other committees may from time to time be created by approval of the membership."

As mentioned, versions of the pandemic-related revisions were made for International, District and Club bylaws. All revisions were effective immediately. Detailed information on all bylaw changes will be on the International website soon under the Governance Tab.



International Foundation & Grants

At the 2021 Altrusa International Convention in Charlotte, North Carolina, Karen Robinson (District Three, Tampa Bay, FL), Jane Hart (District Eight, Greater Kansas City, MO) and Phyllis Corman (District Two, Centre County, PA) were elected as Directors to the Altrusa International Foundation Board. Leslie Johnson of District Eleven will serve as the new International Foundation Chair. Past Governor of District Three, Linda Robison, will serve as Immediate

Past Chair. Congratulations, Karen!

For the Spring Back Into Things fundraiser, the Foundation raised \$102,161.69 dollars, and appreciates the support of the membership and clubs. The Fundraiser was a challenge to the clubs and service grants were given to several clubs with the largest gifts and largest gifts per capita.

Altrusa Clubs may submit applications for International Foundation Project Grants. The clubs may request between \$250.00 and \$4,000.00. Eligibility requirements include involving Altrusa club members in hands on



participation and other possible criteria such as is literacy based and improves participants' literacy skills, benefits abused and battered women, or benefits the aged, along with many other possibilities. The complete list is available with the criteria and other guidelines for the application at the International Foundation website, https://foundation.altrusa.org/grants-awards/. Follow up information is required if the grant is given, and that form is also available through the website. In the Fall of 2020, the Grants Program awarded (48) Altrusa Clubs a total of \$148,182 in funding for the development of their community service projects. The next application due date is September 15, 2021, followed by the second cycle date of March 15, 2022.

2021 International Foundation Inc., Grants Program Winners from District Three

Statesboro Georgia Grant Awarded \$2,000.00 Books for Backpack Buddies

In efforts to help students learning we have increased our reach to Kindergarten classes in our Three Title I schools. The Read to Me project we began last year now has been expanded we have continued giving all pre-k students a book a month as well as our Books for Backpacks Buddies program. This last month we gave out 1,049 books and over the course of eleven years of our projects we have given out 66,488 books so far.

Raleigh North Carolina Grant Awarded \$2,000.00 Sweeter Dreams for Babies

Sweeter Dreams for Babies provides a bedtime reading package to low-income families receiving cribs from The Green Chair. The target population is babies and their parents. The objective is to encourage reading together at a young age. We were approached by a school social worker as a partner for the crib project. We coordinated purchasing and filling a reusable bag to include two board books, burp cloth, teether, soft blankie and bilingual card promoting reading to babies. Regular bedtime reading encourages literacy and a lifelong love of reading.

UCP's early childhood educational programs serve children with and without disabilities from birth to 5th grade. Instruction is individualized for The final concept consists of: each child and daily routines encourage play, exploration, socialization and hands-on learning. Individualized lesson plans are designed to develop fundamental language and reading skills enhancing gross and fine motor movement, creative abilities, and sensory experiences.



The school corridors include viewing windows into each The rooms, as well as the corridors classroom. themselves, are alive with engaging activities to stimulate learning. Toward the conclusion of the school tour, we visited the teacher's lounge where a new food pantry had recently been installed. A grant is helping to stock the pantry with necessary items for food insecure families identified by case managers. After further discussion, an idea evolved to supplement the pantry with birthday party supplies for families who might not otherwise be able to afford them.

As a part of defining this project, a sample "Birthday In A Box" was assembled.

Most of the supplies were purchased from Dollar Tree

Martha Tootle Cain Scholarship

In the early 1990's, Dr. Martha Cain, professor of chemistry at Georgia Southern University and charter member of Altrusa of Statesboro, recognized the need financial support many young women have when seeking further education. proposed and provided the seed money to establish a scholarship to assist female applying for entrance students institutions of higher learning in our county. Successful applicants should demonstrate maturity, a desire to succeed in the workplace, and have financial need. Upon Dr. Cain's death, the scholarship was named The Martha Tootle Cain Scholarship.



Criteria for the Scholarship were

established. The scholarship award was \$500 per academic term and could be applied towards tuition, books, and/or required fees. Recipients were required to be full-time students at one of the following: Ogeechee Technical College, East Georgia College or Georgia Southern University and must maintain a minimum of a 3.0 GPA.

The application process begins in the spring of each year when high school and college counselors are sent information explaining the purpose and selection criteria. Completed applications are returned to Altrusa for review by the Scholarship Selection Committee. Interviews are then scheduled with the Committee for those applicants who meet the stated criteria, and the selected application is presented to the entire membership for approval. Each applicant is sent a letter from the Scholarship Committee thanking them for their interest. The selected scholarship recipient is invited to a club meeting to meet the Altrusa members and to give her an opportunity to thank them for their support.

The first Scholarship was presented to a young woman who had been unable to continue her education at Ogeechee Technical College due to financial difficulties. She was provided the Scholarship for more than a year and in addition was mentored throughout her studies by Dr. Cain. In the years since the inception of the Scholarship, women have completed courses of study in education, nursing, child care, sonography and welding.

In 2021, the Altrusa Club of Statesboro voted to increase the scholarship award (per semester) from \$500 to \$1000. With the increasing cost of education, our hopes are that this will make a difference in the life of a student wanting to continue their education. We believe Martha Cain's vision of providing a means for women to achieve their goals for education and success in the workplace is being met by this scholarship.
