



Altrusa District Three Foundation, Inc.

Contribution Form

All levels of giving are acknowledged by a written communication in addition to an annual listing in the final issue of the DSB each year.

Contributor - \$50.00 - \$99.00

With a gift of \$50.00 to \$99.00, an Altrusan becomes a Contributor of the Altrusa District Three Foundation.

Sponsor - \$100.00 - \$249.00

For a one-time gift or cumulative gifts totaling \$100.00, a contributor becomes a Sponsor. When the Sponsor's cumulative gift reaches \$250.00, the Sponsor moves to the next category.

Partner - \$250.00 - \$499.00

For a one-time or cumulative gifts totaling \$250.00, a contributor becomes a Partner. When the Sponsor's cumulative gift reaches \$500.00, the Sponsor moves to the next category.

Governor's Circle - \$500.00 - \$999.00

For one-time or cumulative gifts of \$500.00, a contributor joins the Governor's Circle. In addition to any written acknowledgements, the contributor receives a memento noting their entry into the Governor's Circle at the annual meeting of the

Foundation. When the Governor's Circle cumulative gift reaches \$1000.00, the contributor moves to the next category.

Mamie L. Bass Society - \$1,000.00 +

For a one-time or cumulative gift of \$1,000.00 or more, a contributor joins the Mamie L. Bass Society. In addition to any written acknowledgements, the contributor receives a memento noting their entry into the Mamie L. Bass Society.

Benefactor - A Benefactor includes the Foundation in their will or makes the Foundation beneficiary of an insurance policy. When a person notifies the Foundation that the District Three Foundation is included in their will or is listed as the beneficiary of an insurance policy, the Altrusan is added to the Benefactor list. Acknowledgement will be sent to the family upon receipt of a bequest or an insurance payment.
