In the Spring edition of the DSB (published 6/3/2021) there was a call for Nominations. Attached is the form to be used to nominate a candidate for an office on the District Three Board. You can also obtain a copy from the website (<https://districtthree.altrusa.org/about/district-and-club-policies/>).

We ask that you please consider submitting the name of a candidate for office for the 2023-2025 biennium. We need good leaders to continue the forward momentum of our District and Altrusa overall.

Please keep in mind:

- The District Three By-Laws make it possible for two members of any club to hold District office at the same time.
- Someone currently on the Board may be nominated, but not for their current office.
- To be eligible for election to the office of Governor-Elect, the candidate shall have previously served a full term (more than half of a two-year term) as a member of the District Board.

To be eligible for a District office, except the office of Treasurer, the candidate must have completed one full term as club president or be serving as club president at the time of the election. In accordance with District By-Laws, a candidate for Treasurer must have served a term as President or as Treasurer of an Altrusa club or be serving as the same at the time of the election and also have general accounting knowledge or experience.

The board positions open for nominations are:

Governor-Elect  
Vice Governor  
Treasurer  
Director (3 open positions)

Our committee is confident you will seek out the most qualified candidates. I look forward to receiving a submission from you **no later than August 15<sup>th</sup>**. If you have any questions, please do not hesitate to contact me or any member of the Nominating Committee.
