District Three Awards

The Mamie L. Bass Service Award

The Mamie L. Bass Community Service Award was established by the International Board of Directors in July 1963, as a memorial to the first National President of Altrusa. The name was changed to the Mamie L. Bass Service Award by the International Board of Directors in July 1975.

Objectives:

- 1. To stimulate interest in developing action programs in the community that fall within the scope of Altrusa's program of service.
- 2. To encourage members of local Clubs to participate actively in service projects designed to meet specific local needs.

The Letha H. Brown Literacy Award

The Letha H. Brown Literacy Award was established by the International Board of Directors in July 1993, to honor Past International President Letha H. Brown, who, in 1977, introduced literacy as a major emphasis of the organization.

Objectives:

- 1. To stimulate interest in developing active literacy projects to serve their community.
- 2. To create an awareness of Altrusa and its commitment to literacy.
- 3. To encourage members of local Clubs to participate actively in literacy projects designed to meet specific community needs.

Dr. Nina Fay Calhoun International Relations Award

The Dr. Nina Fay Calhoun International Relations Award was adopted in 2003 as a memorial to the only International President who served two terms and who focused on the international aspect of our organization.

Objectives:

- 1. To encourage and to stimulate international relations.
- 2. To create an awareness of other cultures and people of the world.
- 3. To recognize outstanding club achievement in international relations

District and International Competition

Service projects nominated for the Dr. Nina Fay Calhoun International Relations Award are judged each year at District Conferences. First-place winners from each District are entered in the competition at International. Established judging criteria are used by Districts and by International.

One (1) service project from Clubs-At-Large is included in the competition at the International level. The International Membership Committee organizes the selection process for projects for Clubs-At-Large.

Ernestine Milner Program Excellence Award

Purpose:

This award is based on the concept that good program planning is the key to a successful club. Ideally, programming should provide Altrusans with opportunities for fellowship, service, personal and professional growth in addition to influencing member participation and attendance.

Outstanding Community Service Award

Objectives:

To stimulate each club to make community service a priority focus of their club by demonstrating at least a minimum percentage of membership participation, finances and volunteer time in their community service activities.

To recognize each club that achieves these goals on an annual basis.

Newsletter Award

Purpose:

To promote effective communication within and beyond the club. Club newsletters are intended to be timely, concise and reader-friendly ways of communicating with current and potential members of Altrusa International, Inc. Electronic distribution makes that cost effective, timely, and possible for all.

Todd Jordan Yearbook Recognition

Objectives:

To stimulate each club to make member communications a priority focus of their club by demonstrating that the following information is included in their Yearbook. By following the guidelines set forth below, a club can be assured of foundational communication for club members.

To recognize each club that achieves these goals on an annual basis.

Extension Award

Objectives:

To encourage clubs to expand awareness of Altrusa as a vital part of the service community by making extension a priority focus of their club.

To recognize, annually, each club that succeeds in the chartering of a new club.

Membership Awards

The Myrtice H. Price Membership Award, New Member Incentive Award, and Membership Greatest Net Gain awards are determined by the District Three Treasurer according to membership records as of January 31, 2024. These awards are incentives for clubs to keep their membership rolls current and any changes up-to-date with the District Treasurer.

The Lake City Club won **First Place** for the Mamie L. Bass Service Award with their project, *"Full Tummies, Full Attention: Backpacks of food for Hungry Homeless Students."*

By partnering with community businesses and individuals, Altrusa provides healthy, easy to prepare foods that are kid-friendly to school age children so they will not return to school on Monday hungry and unable to focus. While also making as many as possible aware of the needs of our Homeless Education Initiative. We added some books too- feed the mind!

Approximately 36 weeks during the school year, backpacks are supplied to 40 students. A typical

weekend bag is filled with 2 breakfast items, 2 lunch items, 4 snacks (fruit when we can) and 4 drinks (milk, chocolate milk, 100% juice and water). We also attempt to make the items as healthy as possible. Recognizing that the child may not have a way to prepare or even open these items, we provide "pop top" cans with ready-to- eat items. Some three day weekends are included in this schedule. Things we take for granted like toothbrushes, toothpaste, and other self-care items are included annually as well.

Interested in expanding your club's capacity to *Build a Better Community*? Consider starting an ASTRA Club in your area. Complete information on ASTRA is located at <u>https://astra.altrusa.org/</u>. You would be working with the ASTRA Club policies established by Altrusa International. ASTRA Clubs can be sponsored in a:

- Middle School
- High School
- Home School
- Vocational School/Occupational Center
- Community College
- College / University
- As a Community club on its own -- ASTRA Club of Any town

You must be prepared to be flexible in also following and establishing guidelines set by a school as long as they are not in conflict with the Bylaws and Policies of Altrusa International, Inc. An important factor to consider if you are looking at starting a club in a school situation is to have a contact person or advocate within the institution to guide and assist you through their system.

ASTRA service projects can receive financial resources via the following :

- ASTRA Clubs are eligible for Altrusa International Foundation Grants to fund their community service projects requesting up to \$4,000 for one service grant per year. Information can be located at: www.foundation.altrusa.org
- ASTRA Clubs chartered September 1, 2019 or later may receive a one-time grant up to \$2,000 to begin service in their communities. The grant recipient is obligated to use the grant award for the intended purpose and must file a report within one year after the grant is awarded. Applications must be received within one year of the charter date.
- The District Three "KM ASTRA Grant Fund" was created in 2021 in honor of Governor Kitty McElhaney to provide District Three ASTRA Clubs a source of funding for service projects. All District Three ASTRA Clubs are eligible to complete an application requesting up to \$150 annually until all funds are depleted. All under charter strength clubs in District Three may submit a Club Revitalization grant proposal for consideration by the Board of Directors of Altrusa International District Three, Inc. Funds provided by the grant may be used in a variety of ways to benefit each club as it sees fit for printing brochures and invitations to recruitment events, postage, ads in local media, the purchase of Altrusa membership kits, pins, etc. Clubs are encouraged to define their needs and decide on a plan of action to grow their membership.

Letters and copies of the application and grant guidelines have been emailed to the presidents of current under charter strength clubs to advise them of the grants and to encourage them to submit grant applications.

INTERNATIONAL BRR ADOPTIONS IMPACTING CLUB BY-LAWS

Jane Gray BRR Committee

Actions That Changed the District and Club Bylaws

Bylaw changes at Convention can be significant and result in lengthy discussion at the Business meetings. While there were a couple of changes at the 2023 Convention that have changed International, District and Club processes, the discussion was productive and essentially makes them clearer and more consistent in their order within the affected Article. Thank you to our District Three Champs, Colleen Duris, International Parliamentarian, for her work in preparing the amendments and Donna Johnson, Past International President, for presenting the amendments at the business meeting.



INTERNATIONAL

The first amendment was to Article X, Section 1 by adding the United Nations as a Standing Committee of Altrusa International. It was adopted unanimously. There was a small increase to the budget for the United Nations Chair and the current BRR Committee Chair.

The next amendment to Article VI added the phrase "or a Special Meeting" after the word "Convention" in Section 6 and 7 and clarified the way special meetings to Convention would be handled. They were found by the BRR Committee and Colleen to be inconsistent in order of presentation. Changing the order made them easier to follow. Everyone agreed and the amendments passed unanimously.

DISTRICT

For District meetings, Article VI was further amended. The result of the Convention vote was as follows: Section 5 of Article VI was renumbered as Section 2. Section 2 was renumbered as Section 4. Previous Section 4 was renumbered as Section 5 and deletes "Conference" at the end of the sentence and substitutes "Special Meeting". Section 6 covers what constitutes a Quorum at Conference and now reads: A majority of the members registered at a Conference *or Special Meeting* who are entitled to vote shall constitute a quorum. The majority vote of the members at a meeting at which a quorum is present shall be the act of the members of the District, except as to amendments of these Bylaws, which are covered by Article XVII, Section 1 and except as otherwise provided in these Bylaws. Section 7 regarding members entitled to vote adds "or at a Special Meeting" to the end of the first sentence.

CLUB

The amendments to Article VII were also directed at clarifying the meetings of Clubs. The debate centered around the differences among our clubs as to when they hold their annual meetings. They range from April to September! The proposed amendment would have moved Section 3 to Section 1 and read:

Section 1. Annual

The annual meeting shall be designated by the Board of Directors and shall be one of the regular meetings in June of each year. After discussion, the vote was almost unanimous to simply end the sentence at "Directors". The remaining effect of the amendment was to renumber the remaining sections appropriately after Sec. 3 moved to 1.

Did you hold the door for someone, allow a car to merge ahead of you in traffic or smile at someone as you passed each other? If so, you made a difference in someone's life.

Time to start thinking about your "Make a Difference Day" service project. Traditionally they are usually held in October, but you can schedule yours for a time that works best for your club.

"Make a Difference Day" projects are usually small projects that can be accomplished in a single day or meeting. You can schedule a food collection for your local food bank or maybe diapers and baby items to be donated to a clinic that serves lower income families. Look around your community, opportunities abound.

Once you select your project, be sure to take pictures. Then when you have completed your project, someone in your club needs to write a short article and send it to Dimple (her email is at the end of this DSB) to be published in the next DSB. Remember one of the categories for the Governor's award is to send in two (2) articles per year to DSB.

We have been challenged by our new International President, Linda Smith, for each member to do 1 random act of kindness per week. That would equal 300,000 acts of kindness per year.

In this biennium, we will continue to support Days for Girls. Go to <u>https://www.daysforgirls.org</u> to find a center or click on the WAYS TO GIVE tab. In addition, the Million Book challenge is continuing. Keep track of books and literacy service hours.

As a last note, we have been charged by the 2023 conference co-chairs to do an environmental service project.

The Convention is San Antonio was fabulous. It was so great to meet so many of you there and I look forward to working with all of you to make this a great biennium.






Our Altrusa International Club of Charlotte, NC Inc. is excited to be supporting the **One Million Book Service Challenge** through our partnership with the Charlotte based **Promising Pages**.

Eric Law, the Executive Director from Promising Pages, spoke to our club at our August Monthly Meeting and shared, "All children need books in their homes in order to grow academically, but there are an estimated 60,000 children in the Charlotte area living in a book desert." We've heard of food deserts where individuals are unable to find nutritious foods and vegetables in their neighborhoods. A book desert was a new term for us. The situation is dire. We were aware that home libraries are often seen as a luxury for children and families in these underrepresented communities. We were not aware of the map which clearly defines the book desert areas. "Promising Pages collects new and donated books and distributes them to students and organizations, with the goal of eliminating the book desert and providing a free resource to those that need it most."

The club is in the planning stages for our month-long book drive to coincide with **Make-a-Difference Day** in October. We are identifying locations like fall festivals, green areas (areas were books are plentiful) and local businesses where we will have the opportunity to place collection bins and spread the word throughout the community. We will eagerly provide an update in the next DSB, but wanted to share what we have learned about <u>www.promising-pages.org</u>.

A year ago in September 2022, one of our Altrusans, with a good friend, Lyuba, from Ukraine, began collecting clothing and other requested items to send to a population traumatized and displaced by war. During the year, that benevolence grew from one member's efforts to a club outreach overseen by our International Committee. It even became a city-wide endeavor because of several reasons:

We had just voted to discontinue our popular fundraiser, Trading Closets, and many of our faithful donators had closets full of shoes and clothing for Altrusa. Thousands of wonderful items including leather coats, fur coats, boots, hats, gloves, warm and beautiful clothing poured in and Altrusans helped sort, weigh, label items and pack boxes. Prep for shipping is an arduous task, but Lyuba guided us and fed us Ukrainian snacks as the project grew and grew.

As Lyuba was familiar with her country and has family and friends there she could direct donations to some specific orphanages, improvised campsites, churches, and other agencies in Ukraine helping the effort. We met needs as they arose. Little flashlights helped calm frightened orphans. Dried meat and fruit, and especially peanut butter was tucked into boxes of clothes. Soldiers needed soft tee shirts and we had hundreds and hundreds for them.

Bandages and medical supplies were donated by community members and groups with Altrusan friends. Whatever was needed seemed to appear and thank-you letters and photos began coming to Lyuba who translated and shared them with us. Our club is now connected to and captivated by these brave, creative and kind Ukrainians. International Committee's upcoming community fundraiser will be an upscale dinner featuring Ukrainian dishes prepared by the committee (with much help from Lyuba) and money raised will go to the war (and hopefully soon recovery) effort.

Backpacks, Books and Birthdays....Oh My....

Altrusans from the Orlando-Winter Park club gathered at a local Orlando National Guard Armory on July 27th as part of the Back to School Brigade to help with start of school preparation for military kids in the Orlando and surrounding areas.

As part of a multi-year ongoing cooperative project with Operation Homefront, several Altrusans sorted school supplies collected from various local Dollar Tree stores then stuffed 120 backpacks for elementary, middle and high school students from military families.

On Saturday, July 29th, they were back at it again, this time helping hand out backpacks to the families and students. In addition to the donated school supplies, Altusans also brought a variety of activity books spanning elementary, middle and high school levels for the students to pick for themselves. There were lots of smiles and excitement as the students explored the "goodies" in their backpacks and picked activities books that interested them the most.

The Altrusans were also able to distribute many of the remaining school supplies to Orange and Seminole county organizations that provide them to teachers to help supplement supplies in the classroom for the 2023-2024 school year.

At the end of the backpack stuffing activities on Thursday, Altrusans also put together 16 "Birthday in a Box" packages and delivered them to the United Cerebral Palsy *UCP) of Central Florida schools. UCP of Central Florida operates eight special schools focused on creating an inclusive environment where children with and without disabilities learn in the same classroom support from a cadre of instructional and medical professionals. The Orlando-Winter Park club has a close working relationship with UCP and during a tour of one of the schools an idea evolved to supplement their existing food pantry system with birthday party supplies for families who might not otherwise be able to afford them. An Altrusa grant helped start the program which is now funded in the club's operating budget annually,

providing "Birthday in a Box" packages to all 8 schools on an annual basis.

In 2001, it was renamed in honor of Sister Helen Wright, the agency's first director. On Tuesday, August 1, six members served a meal at the HWC, which opened in 2020. Our partner from Highland United Methodist Church, Barbara Knight, provided all of the beverages and homemade desserts.

Altrusa International of Starke, Florida is off to a good start for the new year. While we are eagerly preparing for our annual Gala to fund all service projects for the year, we have been blessed to secure several grants supporting literacy and education in our county. Our educators have committed themselves to "Breaking Barriers" and accomplishing things never done before in Bradford County schools.

In early 2023, we applied for a grant with Clay Electric and received \$10,000 to support a literacy project for the three



elementary public schools in Bradford County. The program started in the Fall, but they needed additional funding to complete the year. The program is called UFLI (pronounced "You Fly") and it is an explicit and systematic program that was created by a team at the University of Florida for children in kindergarten through 2nd grades. Bradford schools saw a significant drop in reading scores after kindergarten in both 1st and 2nd grades, and the UFLI program seemed to be a good solution to help with the problem. Teachers are provided with detailed, but easy to follow lessons for students to become good readers. This program engages both the reader and the teacher, and UF sends students over to help in each school. Results for this school year showed significant improvement in reading scores and is being continued in the schools again this year. Our Altrusa members are delighted to be able to support this new literacy program.

In April, we applied for another grant from our local Capital City Bank. We were awarded a \$1,000 grant in May to help Bradford High School with the

start of their new Cambridge program. This program helps students to achieve an AA degree at the same time they graduate from high school, and it increases the number of students that achieve the Bright Futures status that pays for their continued college courses required to achieve a Bachelor's degree. Our members are looking forward to supporting and hearing about the progress of this program during the 2023-2024 school year.

In addition, we received an International Altrusa Foundation grant for \$4,000, with a club support of \$1,000 focused on STEM for two of our elementary schools that are going into their third year of offering this program. The funds provided several Lego projects for Lawtey Elementary, our smallest school, and a moving lab for Starke Elementary, which can be used in different classrooms as needed and will be used in their outdoor gardens that each class has in and around their school. The equipment has been ordered and should be in by very soon.
